ATTENDANCE:

Secretary Kelly Brasher called the meeting to order at 5:26 in unit 205.

Treasurer's Report:

Bill reported that all bills are current for the month. Orkin was inadvertently paid twice by the bank for the annual termite treatment but the bank and Orkin are aware of and rectifying the issue. We are ending the year with \$50,000 in two Certificate of Deposits, both due to mature in July of 2025. They will be available for use if needed for any unanticipated insurance increase.

The preliminary budget for 2025 is attached for your review. Bill explained that he has budgeted a 10% projected increase in flood insurance and \$250,000 for insurance for next year. A motion to accept the Treasurer's report was made by Raymond May, seconded by Linda Elledge, and passed unanimously.

President's Report

President Pro Temp Emile Hebert reported that the bids that were approved at the last meeting were just waiting on the weather to clear to start work. Emile also reported that they are working on bids to replace/repair the roof of buildings on the East side, and they are also waiting on bids to redo the walkways on both the 2nd and 3rd floors on the West side.

- 1. A motion was made by Emile Hebert, seconded by Bill Abraham to spend \$12,145 on repair/replacement of rotten wood rafters/beams, painting of any unpainted rafters, repair/replace a piece of the dumpster fence on the East side, and replace two of the solar streetlights. Motion passed unanimously.
- 2. A motion was made by Emile Hebert, seconded by Raymond May, to spend \$1950 to repair/seal leaking gutters and downspouts. Motion passed unanimously.
